### 25.48 Matters arising

- 48.1 Speed signs update: Cllr Prowde advised that he was negotiating a price reduction with Swarco and was visiting them next week to see a demonstration of the new software. This project is now going ahead, our two existing signs have been taken to Swarco for updating to Solar. The hedge on Sterne Close is still an issue and needs cutting back. Cllr McMeekin to ask Cllr Taylor if this is the responsibility of Highways Action Cllr McMeekin.

- 48.3 Yorkshire Water manhole overflowing. Cllr Knighton advised that YW had been out and spent considerable time clearing it out.
